Apply liberally by spraying the equipment and allow to run off.

Directions

Shake can before use for approximately 30 seconds. Remove protective cap. Hold can upright. Spray from 6 - 8 inches. Test on small area before using. Do not use on sensitive equipment: Computers, VCR's, and Stereo Equipment. Remove heavy contaminants and deposits by scraping. Apply liberally by spraying and allow to run off.
